## NOTED AREA WRITER TO SPEAK JANUARY

Author James D. Snyder, who has written three books on South Florida history, will be the featured speaker at the January 17, 2005, meeting of the Boynton Beach Historical Society. The meeting is scheduled for 7:00 p.m. at the Boynton Woman's Club, 1010 South Federal Highway.

A lifelong journalist, Mr. Snyder spent over thirty years in Washington, D.C. as a governmental affairs writer, magazine editor and Chairman/CEO of a business periodicals publishing company. His presentation will combine information from his research for the books about South Florida. These are Life and Death on the Loxahatchee: The Story of Trapper Nelson; Five Thousand Years on the Loxhatchee: A Pictorial History of Jupiter-Tequesta, Florida; and the most recently published, Black Gold and Silver Sands: A Pictorial History of Palm Beach County Agriculture.

The Historical Society of Palm Beach County published the book on Palm Beach County agriculture with the concern for preserving information on the farms that once covered the major portion of the County. Many people from the Boynton area with farming connections contributed directly to the research, among them several members of the Boynton Beach Historical Society including Billy DuBois; Harvey E. Oyer, III; Sandy Simon: Roy Simon: and C. Stanley Weaver. Many other names of people prominent in farming in our area are mentioned in the book. Mr. Snyder will have copies of his books available for sale and will personally autograph any purchased. 
Boynton Inlet Docks - Very Late 1940s

#### A FISH (or Fishy) TALE - MAYBE

In the 1970s **Vernon Lamme**, a long time journalist and the associate editor of the *Boynton Beach Star*, published a little paperback entitled *Florida Lore Not Found in History Books*. Although the stories concern happenings all over Florida, one in particular caught your editor's eye and is called "A Sure Enough Whopper." It concerns a "fish" presumably caught off the southeast coast of Florida in 1912. According to reports, "It took several days and many hundreds of high powered rifle bullets to subdue." The picture is supposedly "untouched" and a model of the fish has not been superimposed.

Reports suggest it was shown in Palm Beach on a large barge by a Captain Charles Thompson who took his fish across the nation to show to school children (for a small fee, of Eventually it could no longer be preserved. Lamme credits Fred Benson of Boynton Beach with finding this photograph in San Francisco. He acknowledges that the weight on the photo, 30,000 lbs., may be "a slight exaggeration" as there were no scales capable of weighing such a large catch. But reportedly it did measure 45 feet in length. Lamme reports that his son Bob could recall the time when he was about three years old and his grandfather Captain Tony Canova introduced him to Captain Thompson who picked him up and placed him in the "yawning mouth of the monster."
