## JOHN MARTIN TUITE— In his Own Words

[Ed. Note: The following has been edited slightly to fit in space in *The Historian*.]

"Born 1-10-18 Bronx N.Y - married Mabel C.

Rousseau 8/5/42 Primary School--

P.S. 72 - Bronx N.Y.

Central Elementary W.P.B. FL 1927-28

St. Ann's Academy N.Y. C. Graduated 1932

High School--

Pelham Memorial High – Pelham Manor N.Y. Graduated 1936

College--Thomas R. Clarkson Memorial College of Technology 1937

Left due to health of father & mother

"After leaving college – employed by Methodist Book Co. – Printing and Bindery Work. Joined N.Y.S. National Guard, Co. C 165 INF –Yonkers N.Y. – Also enrolled Delahanty's School (Prep for Fire Dept – was member of Aviation Vol.F.D. Clason Point N.Y.)

"August 1938 moved permanently to family home on Pine St. Boynton Beach, FL – after death of father.

"Previously had been a winter resident of Boynton – When I was a seasonal visitor I was classified as a 'Yankee' When I moved here permanently I was classified a 'Damn Yankee' because I came & stayed. When I married my wife, a Boynton native, I became a 'G.D. Yankee.' (Continued on page 3)

"In retrospect - Even though we had moved permanently to Boynton in 1938 - Lack of work due to economy & weather it behooved my mother & myself to return to NYC for short periods of time.

"On Dec 7, 1941, I was on duty at Aviation F.D. when word was received on Pearl Harbor. My name being on roster at the New York State National Guard, I was ordered to report to the Armory P.D.Q. We were released to go home, on Stand-by, after 72 hours.

"As soon as I reached home, my mother & I packed car w/our belongings and headed back to Boynton Beach. On the  $16^{th}$  of Dec. 1941, . . . I took the written test for aviation cadet.

"Between Dec 16 '41 & April 3 '42, I spent 2/3 days a week going to Morrison Field West Palm Beach for additional testing & indoctrination; finally sworn into the U.S. Army Air Corps on April 3<sup>rd</sup>, 1942. . . . reported for Camp Blanding FL duty June 1 1942 . . . shipped to San Antonio Tex. San Antonio Aviation Cadet Training Center 'Class 42 C.'

"Shortly after arrival at San Antonio, a hurricane hit San Antonio. All cadets were pressed into emergency services.

"From San Antonio went to pilot training at Spartan Air Craft School Tulsa, OK – Sept.'42. ... ordered to Garden City Army Air Corps Base, Garden City KS.

"Retrospect—During time was awaiting call up to Air Corps, was active in Boynton as Vol. Fire Fighter, Reserve Police Officer, First Air Instructor in Civil Defense Program, Civil Defense Beach Patrol. Assisted rescue operation when ship torpedoed off Boynton Inlet.

"Having had civilian experience as fire fighter & police officer was assigned to M.P. Guard Sq. [at Garden City, KS] Winter time in Kansas was beyond imagination. Our barracks were summer time residences. The 4 men who were billeted around the 'pot-bellied' stove were warm (2 stoves per barracks). The remainder of men froze. Feb '43 got flu—spent 10 days in hosp. followed by furlough home.

"Returning to G.C. was assigned M.P duty on town patrol. . . . I was fortunate enough to be invited on a buffalo hunt. Every year they culled out the oldest buffalo in the herd & killed it, giving the meat to Old Folks Home in Finney Co. KS.

"In July '43 my wife Mabel joined me in G.C. Nov. 29, 1943 our daughter Frances was born. Kansas was in the midst of a 'Gut Bustin' Snow Storm.' The only vehicles moving on the streets were police cars. Mabel & I were transported in police car to Hosp. The state of Kansas paid the Hosp. bill. When it was time to come back from Hosp. Police car again—Mabel had never seen snow before coming to Kansas, 17 [degrees F.] was hard on her. Frances survived 17 pretty well.

"Jan '44 I was placed on overseas ship list. Got furlough to take Mabel & Frances home. Reported to Kearns Overseas Replacement Training Center, Salt Lake City Utah. From Kearns went to Camp Toneman, Stockton CA. From Stoneman boarded the U.SS Republic . . . to New Guinea . . . then on to Hollandia for invasion—after Hollandia, R & R at Townsville Aust.. Then on to Leyte and Luzon. Dec. '45, enough points to return to States. Boarded Santa Monica.

X-mas in San Fran—Camp Blanding for New Year. Home Jan 6 '46.

"3 hours after arrival in Boynton was employed as full time police officer. Dept. strength: Chief & 1 officer—worked Police Dept 3 months, \$150 per month; Resigned—difference of opinion w/Chief over how police work should be done. Active Vol. Fire Dept. Went to work Fire Dept. at Boca Raton Air Force Base. Worked there until all civilian fire fighters were replaced by military personnel to close base. Nov 23' 46, John Jr. born. Worked short period time Lantana City Hall as bookkeeper.

"Dec '46 went to work Palm Beach Police Dept. Resigned June 30 '56 to start work, 1<sup>st</sup> full time paid fireman Boynton Beach F.D. July '56—worked 24 hrs. on, 24 hours off. On off duty days work as Deputy Constable, 6<sup>th</sup> Dist. P.B. Co.

"Jan '59 – City Council appointed me Chief of Fire Dept. requiring me to give up constable job.

"During period was Fire Chief, was Civil Defense Director for City of Boynton. . .President of P.B. County Fire Chief's Association, President of FL State Fire Chief's Association. Designed and with assistance of paid & volunteer firemen built 3 brush trucks , 4 first aid vehicles, installed emergency power in fire station, established fire inspection program, assisted setting up fire safety program for Bethesda Hosp. & established 1<sup>st</sup> aid training at fire station and 1<sup>st</sup> aid swimming classes in summer.

"Retired Mar '64.

"Went to work P.B.Co. Sheriff's Off. July '64. Retired July'82.

"Lost Mabel May'92.

"July '92 QM. V.F.W 5335."

#### HONORS FOR ART DECO HOME

Linda Stabile's Art Deco home that the Historical Society featured in a program several months ago has recently been placed on the Palm Beach County Historic Registry. It is the first private residence in Palm Beach County to be so designated by the County. The house which sits just off Federal Highway is in a "County pocket" located between Boynton Beach and Delray Beach and is not under the jurisdiction of either city.

Linda Stabile, one of the Society's members, is currently working on a book of pictures of buildings with art deco characteristics that are, or have been, built in the area. Her book should be available in spring of 2007.



James Shelton, one of the Historical Society's current members, has recently sent us a number of pictures. Among them is this photograph of T.A. Ward's store on what is now S.E. Fourth Street, taken in the 1930s. T.A. Ward's daughter, Lou Anna Ward, was James Shelton's mother. At various times, T.A. was a constable, a grocer, and a mail carrier.
